Covenant of Care Policy #1 re: Movies

- 1. That ratings established by the Saskatchewan Film and Video Classifications Board http://www.fcaa.gov.sk.ca/CPD-SK-FCB be adhered to as part of Catechetical program for children and youth as well as, if applicable, camp policy, with (14A) being the highest rating that will be considered as long as all of the youth involved are 15 or over. If the youth involved are younger than 15 the highest rating will be PG. These guidelines are as follows (from the Saskatchewan Film and Video Classifications Board):
- · General (G);
- Parental Guidance (PG):
- 14 years of age or older or under 14 if accompanied by an adult (14A):
- 18 years of age or older or under 18 if accompanied by an adult (18A);
- Restricted (R); and
- · Adult (A).

In addition, each film is required to list required informational advisories such as: not recommended for children, mature theme, language may offend, coarse language, crude content, violence, brutal violence, sexual violence, nudity, sexual content, gory scenes, frightening scenes, disturbing content, or substance abuse. (section 6, regulation 16) *(See e comparable ratings from the US.)

- 2. The persons choosing the movies will also avoid movies with content advisories of severe violence, nudity and a great deal of crude language or behaviour that is in any way demeaning to our humanity, especially when being shown to youth under 18.
- 3. If the supervisors/ catechists decide to show clips as part of a lesson or catechetical teaching from movies that that are above the designated rating or with objectionable content they may, as long as the objectionable parts are removed.
- 4. All movies must be "pre-screened" by the directors or supervising adults plus some additional research should be done as to objectionable content on such sites as:
