RESCRIPT

Permission to Relegate a Church Building to Profane but not Sordid Use

Whereas:

- A. The Ukrainian Catholic Parish of the Holy Eucharist at Cudworth, Saskatchewan of the Ukrainian Catholic Eparchy of Saskatoon has only a few remaining parishioners.
- B. As a result of the above-mentioned lack of parishioners, maintenance of the church building located on Surface Parcel 166033717, legally described as Parcel JJ Plan 102071764 Ext 0, has become too great of a financial burden for the remaining parishioners.
- C. That building is no longer used for Divine Worship. The last Divine Liturgy was celebrated on August 7, 2022 and there is no possibility of restoring the church building to active use.
- D. The parishioners continue to be pastorally served by the priest assigned to the Cudworth Pastoral District and liturgical services are being held in the chapel at the local nursing home and, in the summer, services may also be held at the Shrine of Our Lady of Sorrows.
- E. There has been consultation with the Presbyteral Council of the Ukrainian Catholic Eparchy of Saskatoon regarding the relegation of the church building to profane use at a

duly constituted meeting held October 11, 2022, with unanimous consent having been given.

- F. All sacred items have been removed from the church building. The cross affixed to the exterior of the church building which identifies the building as a place of worship is still affixed to the building but arrangements are being made to remove it.
- G. With the exception of the remaining parishioners who have requested that the church building be sold, there are no parties remaining who have a legitimate claim of rights over the church building.

Now therefore, I, the undersigned Vicar-General of the Ukrainian Catholic Eparchy of Saskatoon, in the absence of the Apostolic Administrator, Most Rev. Lawrence Huculak, OSBM, make the following Decree:

1. That pursuant to CCEO c. 873, the church building formerly utilized by the Ukrainian Catholic Parish of the Holy Eucharist at Cudworth, Saskatchewan of the Ukrainian Catholic Eparchy of Saskatoon be reduced to "profane but not sordid use".
2. That the said property be sold provided that:
 - a. The buyer(s) of the property must undertake to use the property for "profane but not sordid use".

I ORDER the promulgation of this decree through its publication on the Eparchial website.

This DECREE will take effect immediately upon publication.

GIVEN at Saskatoon, Saskatchewan under my signature and under the seal of the Ukrainian Catholic Eparchy of Saskatoon, and bearing the countersignature of the Chancellor, this 21 day of November, 2022.
